

# Authorized Persons Outside Residence (APOR) under ECQ and GCQ (Updated as of May 5, 2020)

### Manufacturing

Employers and workers involved in the manufacturing of the following:

- Basic Food Products, Essential Products, Medicine and Medical Supplies and the entire value chain (raw materials, inputs, including packaging) of:
  - All Food and Beverages (only nonalcoholic)
  - Essential and Hygiene Products (soap, detergents, shampoo and conditioner, diapers, feminine hygiene products, tissue, wipes, toilet papers and disinfectants)
  - · Medicines and Vitamins
  - Medical Products such as PPEs, Masks, Gloves
  - Pet Food
- · Feeds, Fertilizers and Pesticides
- Equipment or Products necessary to perform construction works

#### **Employers and workers of the following:**

- Food preparation establishments insofar as takeout and delivery services
- Retail Establishments (Groceries, Supermarkets, Hypermarkets, Convenience Stores, Public Markets, Pharmacies and Drug Stores)

  - Repatriated OFWs in compliance with approved quarantine protocols
  - Non-OFWs who may be required to undergo mandatory facility-based quarantine

- Pastors, Priests and Imams or such other religious ministers whose movement shall be related to the conduct of necrology or funeral rites
- Repatriated OFWs in compliance with approved quarantine protocols
- Non-OFWs who may be required to undergo mandatory facility-based quarantine
- Those traveling for medical or humanitarian reasons
- Construction workers accredited by DPWH to work in quarantine related facilities and government infra projects
- Workers accredited by DOTr to work in utility relocation works and other DOTr projects
- Employees of Critical Transportation Facilities
- Outbound and Inbound International Passengers and Driver
- One (1) person per household preferably 21 to 59 years old availing essential goods and services within their respective localities



# Not Allowed under ECQ and GCQ (Updated as of May 5, 2020)

The following services and activities are not allowed under ECQ and GCQ:

- · Gyms/Fitness Studios and Sports Facilities
- Entertainment-related Mass Gatherings, including but not limited to:
  - Theaters, Cinemas, Large Concerts, Festivals, Carnivals, Conventions, Shows, Pubs and Bars
- Business-related Mass Gatherings, including but not limited to:
  - Trade Shows, Conferences, Conventions, Workshops, Retreats
- Politically-related Mass Gatherings, including but not limited to:
  - Election Rallies, Polling Centers, Parades, Speeches/Addresses
- Sports-related Mass Gatherings, including but not limited to:
  - Trainings, Games, Tournaments, Championships
- · Libraries, Archives, Museum Operations
- Cultural Shows
- · Gambling and Betting
- Travel Agency and Tour Operations, Reservation Service
- · Activities of Membership Organizations
- Religious Gatherings
