On July 14, 2020, as a result of the STGFVCL meeting, the Secretariat organized a small group meeting on trucking issues, attended by NEDA, LTO, LTFRB, CTAP, and INHTA.

Priority issues raised by the truckers

- 1. Delays in the issuance of Certificate of Public Convenience (CPC).
- 2. Provisional Authority(PA) needs renewal every quarter. Renewal Cost of PA is Php 2,000 to Php 2,500 per franchise of unit.

Agreements:

- Trucking Associations to submit to the Secretariat pending CPC applications
- 2. Invite the LTFRB to present on the issuance of CPC and PA
- 3. Invite World Bank and ARTA to present RIA on CPC
